**POLICY REGARDING THE PROCESSING OF PERSONAL DATA pursuant to Article 13 of Regulation (EU) 2016/679**

**1) Data controller:** the data controller is **PROSIMET S.p.A. (Tax Code. 00747320158) represented by Mr. GIORGIO LUIGI FARAVELLI , located in Filago, via Rodi n. 10, tel. 0039035493897**

**2) Purposes of data processing:** the collecting and processing of your personal data is necessary for the implementation of the contract to which you are party and/or in order to implement pre-contractual measures adopted on your request and/or to comply with your request for information.

**3) Legal basis of the processing:** the provision of data is a legal obligation for the stipulating and implementation of the contract currently being prepared or in force as specified in point 2, and optional in relation to additional purposes of marketing as indicated in point 3.

**4) Communication of personal data:** data collected will be communicated to third parties solely in order to comply with legal obligations. In this case, the communication of data will exclusively regard data necessary for the compliance with said obligation. In particular, the data may be communicated to employees, service or data processing agencies, consultants and accountants, or rather subjects who process data for the fulfilment of specific legal obligations, or Banking Institutions.

**5) The data collected are not subject to distribution, or to any completely automated processing, including profiling.**

**6) Data storage:** personal data will be stored for the duration of the contract, and successively for a further period of storage as prescribed by law.

**7) Rights of the data subject:** you have the right, in the cases indicated in articles 13 and 17 of the Regulation, to request access to your personal data and the correction or cancellation of the same, save for legal obligations of storage. Said rights may be exercised via the channels of communication specified in point 1.

**8) In the case of breaches, you have the right to lodge a complaint to the Italian Data Protection Authority ([www.garanteprivacy.it/en/home\\_en](http://www.garanteprivacy.it/en/home_en)).**
